- Content of photos must be Agricultural Related (example: Crops, Fields & Orchards, Farm Land, Farm Equipment etc.)
- Photos must have been taken within the Fresno County limits
- Photographs must be unframed and not-matted 8"X10" size and can be portrait or landscape layout
- Applicant's name and photo's title must be placed on back of photograph
- Photographs must be brought to the Kerman Senior Center no later than 3pm, Thursday May 4th
- Kerman Senior Center is located at 720 S. 8th Street, Kerman CA 93630 (corner of 8th and "D" street)
- There is no limit to number of photographs
