THE COMMUNITY

The City of Kerman is a small city of 17,535 situated 12 miles west of Fresno in the heart of the agriculturally-rich Central San Joaquin Valley. Kerman is a growing city with a reputation as a safe, fiscally sound and well-managed city.

The City enjoys the benefit of being within close proximity to the Sierra Nevada Mountains, home to Sequoia and Kings Canyon National Parks featuring abundant year-round recreational activities. Kerman continues to grow and many recent developments have added new jobs, property and sales tax revenues to help support ongoing core services to the community.

The City of Kerman is a community with a high level of pride and concern for preserving quality of life. Citizens enjoy low crime, good schools, attractive neighborhoods, parks and recreational activities.

THE ORGANIZATION

The City of Kerman is a General Law City and operates under the Council-Manager form of government. The City is governed by a five-member City Council. The Mayor is directly elected to a two-year term and Council Members are elected to four-year terms by district. The City Manager is responsible for policy implementation and overall operations. The Chief of Police oversees and leads the Police Department for the organization.

THE POSITION

Under general supervision by the PW Lead Supervisor, performs a variety of skilled and unskilled tasks; perform landscaping and maintenance of parks, buildings and roads; and do related work as required.



MINIMUM QUALIFICATIONS

Education - High School Diploma or equivalent.

Experience - Experience in the maintenance field; buildings, equipment, grounds or related fields desirable.

Physical Demands - Activities requiring handling and grasping with the hands when performing repairs or maintenance of equipment by utilizing hand tools, power tools, air tools, nuts, bolts, electronic controls, and other small parts. Occasional use of foot/feet to operate foot pedal on equipment to test operation. Frequent lifting up to 25 lbs., occasional lifting up to 50 lbs., and infrequent lifting up to 75 lbs. Ability to walk and stand on concrete and uneven surfaces for at least 4 hours per day. Ability to bend, kneel and work with arms raised for prolonged periods of time. Ability to climb over and into heavy equipment several times per day. Occasional working at heights above 10 feet. Exposure to bright lights, extreme temperatures, loud noise, dust, gas and/or fumes.

A valid Class C California Driver's license is required at the time of employment.

COMPENSATION

The current salary is \$20.77 per hour. Sick Leave — State Mandated Paid Sick Leave.
